#### 1. Minutes and Actions from Previous Meeting

The minutes from the previous meeting were accepted as a true record of the meeting.

### 2. Project template development and next steps

The benefits of development of a project template were discussed. The aim of which is to provide guidance on the minimum set of information required to aid smaller NGOs/LBAPs in development of funding applications. A number of funding streams are currently underused in Wales such as WREN and SITA and production of best practice guidance or funding proforma may encourage uptake of these funds.

A number of options were suggested, including a peer review system for funding bids, which already takes place already in England and provision of advice in consultation with relevant group in advance of application being submitted. Progression of this work would also be beneficial to other WBP Wales-level groups

**ACTION 1.** JS and HB to discuss taking project template development work forward in consultation with Charles and Sion B.

# 3. Update on on-going projects/Priority Mapping Review

Jan Sherry provided background to the initial priority mapping work, which was completed a year ago. WBP Groups are committed to an annual review of these boundaries and there is a need to discuss whether areas identified are still relevant and review actions which have been undertaken to address issues raised.

ACTION 2. AE to circulate maps to all and collate any amendments following meeting

Charles Morgan provided an update on the Saving Our Magnificent Meadows (SOMM) project, which is part of a wider UK grasslands bid. Total project funding is £3.5m across the UK, with Wales receiving £600k. The project is now in its development year, which is due to finish in June 2013. Forty sites are currently being considered and work being undertaken consists of land owner liaison by consultants on privately owned statutory sites, and liaison work with NGOs with ownership of statutory sites by PONT. Additional work is being undertaken to establishing management requirements on each site.

# ACTION 3. JS to arrange for priority mapping jpeg files to be sent to WG (Arwel Williams)

Looking at commons and improving boundaries to improve ecosystem resilience of those areas. Development of burning plans for commons.

# Gower

Sion Brackenbury provided an update on work being undertaken on the Gower, where the Fire Service have been heavily involved in work and development of burning plans and priority areas.

Work is taking place nationally to develop burning plans. A Welsh Wildfire Strategy is also being developed across all three fire services and it is important that the group be involved in the development.

**ACTION 4.** SB to talk to Brian Harries (FRS), to get update on work being undertaken on the Gower and see if the group can help.

**ACTION 5.** SB to share work with fire plans on Gower and see if lessons can be shared with others areas.

**ACTION 6.** AE to find out what is being done in relation to development of the Wildfire Strategy for Wales and how the group can feed in.

**ACTION 7.** AE to speak to Dai Harries/Kathleen Carroll and discuss how we take burning issues forward. CCW actions agreed at previous meeting have been completed.

## Marshy Grasslands of South Glamorgan

Not much work progressed in this area over the past twelve months. A workshop will be held with LBAPs in the area during June 2013.

**ACTION 8.** AE/SS to arrange marshy grassland workshop in summer 2013, to be hosted by Rhondda Cynon Taff (RCT) and see if any actions can be identified and progressed.

## Llyn Peninsula Coastal Heath and Grasslands

A strong partnership is currently in place between CCW/National Trust/Gwynedd Council/ AONB/RSPB and local landowners. However there have been problems on some sites such as Cilan.

Welsh Government ERD funding was secured to look at quality of chough habitat in nesting/feeding areas to identify problems, due to the significant decline in chough numbers in recent years.

Work has also been progressed on Anglesey looking at heathlands arising as alternative for straw for bedding. A significant number of farmers are now taking up the bedding resulting in the scale of the project being increased and demonstrating the proven economic benefits of cutting heathlands.

#### **Gwent Grasslands**

Melanie Dodd (Caerphilly CBC) is currently developing a funding bid for regional SINC project (SE Wales or Mid Valleys SINCs). Swansea has also finished mapping/review of all their SINC sites in addition to connectivity mapping which has been completed.

**ACTION 9.** AE to get an update on Monmouthshire Natural Assets /Mid Valleys SINC project and provide update to Julia Korn for inclusion in CCWs work on the RDP.

**ACTION 10.** AE to speak to Deb Hill (Swansea CC) for further details on Swansea mapping project, and see if demonstration for LGHEG or urban group is possible.

ACTION 11. AE to draft update on all LA SINC projects for discussion at next meeting.

#### Gwydir Mines Caliminarian Grasslands

Some extra survey work has been undertaken to assess issues however the area is in urgent need of management. Forestry issues need to be addressed as a priority.

#### Floodplain meadows of Radnor/Wrexham

Radnorshire Wildlife Trust (RWT) has a project underway focussed on restoration of floodplain meadows around Llandrindod. Wrexham's one existing site is now under more appropriate management however there has not been any restoration or recreation undertaken.

**ACTION 12.** AE to contact Julian Jones for an update on RWT floodplain meadow restoration project.

**ACTION 13.** SS to speak to Emma Broad (Wrexham Ecologist) and NWWT and see if there is any action which can be taken forward if funding became available.

## Calcareous Grassland and Heathlands of North East Wales

Charles Morgan provided an update on PONTs work in the area. Some sites have been addressed through the Anglesey Grazing Animals Project (AGAP) and other shave secured appropriate management through ERD funding.

# ACTION 14. CM to send Stuart details of grassland site on the Great Orme.

Anglesey Coastal Heath and Grasslands

RSPB have secured WREN funding for work on Penrhyn Mawr.

20+ farmers are now involved in the AGAP scheme and marketing with farmers on Anglesey and Llyn has been well developed and could lead to the development of A Wales-wide conservation grazing strategy, including marketing case studies, different ways of delivering conservation grazing and possible communication with landowners. It was agreed that it would be useful to pull together case studies looking at different approaches to conservation grazing.

**ACTION 15.** ALL to consider maps and note any changes, including any urgent areas which need to be added in advance of next meeting.

ACTION 16. AE to add Outcome of Priority Mapping review to agenda for next meeting.

#### 4. Evidence Gaps

Jan Sherry provided an update on the recent workshop held with academics and Welsh Government in Cardiff museum. The focus of the event was the introduction of new academic representatives on the WBP Wales-level groups and review of the evidence gaps provided by WBP groups. Comments against evidence gaps have been provided by Geoff Profitt (Swansea University) and Mike Bruford (Cardiff University) and there is now a need to reconsider and prioritise gaps and formulate research questions which can be picked up by universities across Wales. Some areas of work may need to be broken down into research 'chunks' and this should be considered as part of the review. Deadline for submission of this work is **20<sup>th</sup> December 2012**

# 5. Phytopthera work.

Sion Brackenbury updated attendees on work on *phytophera ramorum* in north Wales, where control has been successful. Evidence has shown that vacinium is largley being infected by infected larch rather than the other way round and vacinium can be impacted by other diseases, shown by evidence in Holland etc. Most prevalent in the south Wales valleys due to warm moist air rising up from the sea leading to ideal conditions for spread. Most of the infection is in larch and rhododendron.

**ACTION 28.** If 'strange' vaccinum is identified ensure this is reported to Jan <u>j.sherry@ccw.gov.uk</u> or to Fera.

Attendees were also updated on the recent discovery of ash dieback *chalara* and the need to be vigilant and ensure decontamination is undertaken on site if identified.

# 6. Species/Habitat integration work

Jan Sherry updated attendees on progress with the species/habitat integration work which has attempted to identify species niches within habitats and develop management. Habitat requirements, including structure and management, and potential delivery mechanisms have been assessed by species, identifying common micro niches. The work is based on work completed by Natural England (NE) and NE have now taken this further and have been using for monitoring work and encouraging land managers to think more broadly.

The WBP Species Expert Group have completed initial work for heathland and woodland species and this work now needs to be rolled out across the remaining habitats. The current suggestion is that the SEG will focus initially on one habitat per group, enabling groups to develop associated management guidance, ensuring a strategic approach which can be varied site to site.

Jan has completed an initial review of the heathland work and the group now needs to decide how best to take this forward. WG are also interested in this work and have agreed that this should be developed for all remaining habitats, leading to the development of habitat management and/or pictorial guidance. Outputs could also be used to apply management across a suite of sites, ensuring the entire resource is not managed for one species, for example reducing grazing in one area and providing compensation in another (chough).

It was noted that this work could prove useful with regard to grant applications, demonstrating benefits to other species and impacts on others.

GP noted that transition habitats are extremely important and often meeting conditions which CCW insists upon would mean no transition habitat is left, suggesting a mismatch in guidance from CCW at Wales-level and local level, which needs to be addressed.

**ACTION 29.** JS to discuss CCW guidance on transitional habitats with regional colleagues and feedback.

**ACTION 30.** AE to contact NE for copy of pictorial guidance developed and circulate for info. **ACTION 31.** HB to request that SEG focuses on marshy grassland as next habitat for LGHEG **ACTION 32.** JS to circulate upland and lowland heathland table to all.

The LGHEG work programme was circulated to attendees in advance of the meeting, an brief run through of work areas suggests that the majority of work has been completed/progressed as agreed however there is a need to review the document and identify leads to ensure progress is maintained and the work outlined is achievable given current time/budget constraints.
